Fresh air, rest. Artificial respiration may be needed. Refer for medical attention.

Following skin contact

4.2 Most important symptoms/effects, acute and delayed

Exposure can cause irritation of eyes, nose and throat. (USCG, 1999)

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Basic treatment: Establish a patent airway. Suction if necessary. Watch for signs of respiratory insufficiency and assist ventilations if necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Monitor for pulmonary edema and treat if necessary . Monitor for shock and treat if necessary . Anticipate seizures and treat if necessary . For eye contamination, flush eyes immediately with water. Irrigate each eye continuously with normal saline during transport . Do not use emetics. For ingestion, rinse mouth and administer 5 mg/kg up to 200 ml of water for dilution if the patient can swallow, has a strong gag reflex, and does not drool. Administer activated charcoal . Cover skin burns with dry sterile dressings after decontamination . /Organic bases/Amines and related compounds/

SECTION 5: Fire-fighting measures

5.1 Suitable extinguishing media

To fight fire, used alcohol foam.

SECTION 10: Stability and reactivity

10.1 Reactivity

Decomposes on burning. This produces toxic fumes including nitrogen oxides. The substance is a strong base. It reacts violently with acid and is corrosive. Reacts with strong oxidants. Attacks many metals.

10.2 Chemical stability

10.3 Possibility of hazardous reactions

Moderate, when exposed to heat or flame; can react with oxidizing materials. METHYLETHANOLAMINE is an aminoalcohol. Amines are chemical bases. They neutralize acids to form salts plus water. These acid-base reactions are exothermic. The amount of heat that is evolved per mole of amine in a neutralization is largely independent of the strength of the amine as a base. Amines may be incompatible with isocyanates, halogenated organics, peroxides, phenols (acidic), epoxides, anhydrides, and acid halides. Flammable gaseous hydrogen is generated by amines in combination with strong reducing agents, such as hydrides. This compound may react with oxidizing materials. (NTP, 1992)

SECTION 12: Ecological information**12.1 Toxicity**

- Toxicity to fish: LC50 - Danio rerio (previous name: Brachydanio rerio) - > 100 mg/L - 96 h.
- Toxicity to daphnia and other aquatic invertebrates: EC50 - Daphnia magna - 33 mg/L - 48 h.
- Toxicity to algae: EC50 - Desmodesmus subspicatus (previous name: Scenedesmus subspicatus) - 28.1 mg/L - 72 h.
- Toxicity to microorganisms: EC20 - activated sludge, domestic - > 1 000 mg/L - 30 min.

12.2 Persistence and degradability

AEROBIC: 2-Methylaminoethanol, present at 100 mg/L, reached 68% of its theoretical BOD in 4 weeks using an activated sludge inoculum at 30 mg/L and the Japanese MITI test(1).

12.3 Bioaccumulative potential

An estimated BCF of 3.2 was calculated for 2-methylaminoethanol(SRC), using a log Kow of -0.94(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is low(SRC).

12.4 Mobility in soil

The Koc of 2-methylaminoethanol is estimated as 7.3(SRC), using a log Kow of -0.94(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that 2-methylaminoethanol is expected to have very high mobility in soil. The pKa of 2-methylaminoethanol is 9.95(4), indicating that this compound will primarily exist in the cation form in the environment and cations generally adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(5).

SECTION 13: Disposal considerations**13.1 Disposal methods****Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
