SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand-valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR as necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Thiabendazoles and related compounds

12.1 Toxicity

- Toxicity to fish: LC50; Species: *Oncorhynchus mykiss* (Rainbow Trout) length 50 mm; Conditions: freshwater, flow through; Concentration: 770 ug/L for 96 hr (95% confidence interval: 630-950 ug/L) /99.75% purity
- Toxicity to daphnia and other aquatic invertebrates: EC50; Species: *Daphnia magna* (Water Flea); Conditions: freshwater, static; Concentration: 4900 ug/L for 48 hr (95% confidence interval: 3700-6500 ug/L); Effect: intoxication, immobilization /95% purity

- Toxicity to algae: EC50; Species: *Anabaena flosaquae* (Blue-Green Algae); Conditions: freshwater, static; Concentration: 290 ug/L for 5 days (95% confidence interval: 180-510 ug/L); Effect: population abundance /99% purity

12.2 Persistence and degradability

AEROBIC: The half-life of etridiazole in a silt loam (laboratory study) at 25 deg C was 9.5 days under aerobic conditions and 3 days under anaerobic conditions(1). The half-life in a sandy clay loam (field study) was 7 days(1).

12.3 Bioaccumulative potential

A whole body BCF for etridiazole in bluegill (*Lepomis macrochirus*) exposed for 28 days was 193(1). Other reported BCFs for etridiazole were 94 in edible fish tissues, 328 in viscera, and 193 in whole fish(2). Depuration was rapid, at 50% one day after ending exposure(2). According to a classification scheme(3), these BCFs suggest bioconcentration in aquatic organisms is high(SRC).

12.4 Mobility in soil

Koc values of 349 and 323 were reported in sandy loam and silt loam, respectively(1). According to a classification scheme(2), these Koc values suggest that etridiazole is expected to have moderate mobility in soil.

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
