# SECTION 4: First-aid measures

## 4.1 Description of necessary first-aid measures

### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

## 4.2 Most important symptoms/effects, acute and delayed

**SYMPTOMS:** Symptoms of exposure to this compound include erythema, marked pigmentation, dermatitis, patchy hyperpigmentation of the face and neck, and keratomas or epitheliomas of the skin. Corrosion may occur. It may also cause phototoxic reactions of the skin. Symptoms of exposure to a related compound include extreme destruction of tissue of the mucous membranes and upper respiratory tract, eyes and skin, photosensitization, burning sensation, coughing, wheezing, laryngitis and shortness of breath. Inhalation may be fatal as a result of spasm, inflammation and edema of the larynx and bronchi, chemical pneumonitis and pulmonary edema. Other symptoms include headache, nausea, vomiting and allergic skin reactions. It has also caused dizziness, nervousness, insomnia, pruritus, mental excitation, mental depression, acute vesicular cutaneous photosensitization, blistering and, rarely, hypertrichosis, hyperpigmentation, cataracts, liver injury, onycholysis, nail pigmentation, bullous pemphigoid and acneform eruptions. Chronic exposure may cause alteration of genetic material. **ACUTE/CHRONIC**

HAZARDS: This compound is corrosive. A related compound is harmful if swallowed, inhaled or absorbed through the skin. This related compound is also extremely destructive to tissue of the mucous membranes and upper respiratory tract, eyes and skin. When heated to decomposition it emits acrid smoke and irritating fumes. (NTP, 1992)

#### **4.3 Indication of immediate medical attention and special treatment needed, if necessary**

##### **Absorption, Distribution and Excretion**

Micronized bergapten in capsules was absorbed slowly by volunteers (time to max serum concn 3.2 hr; elim half-time about 1 hr). when injected iv into rabbits, elim half-time 1-2 min (alpha-phase) & 15 min (beta-phase).
