SECTION 4: First-aid measures

4.1 Description of necessary first-aid measures

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

4.2 Most important symptoms/effects, acute and delayed

SYMPTOMS: Symptoms of ingestion of this type of compound may include skin rash, urticaria, fever, anorexia and malaise. It may also cause joint pains, sore throat and agranulocytosis. Other symptoms may include paresthesias, headache, nausea and loss or depigmentation of the hair. It may cause dermatitis and thirst. **ACUTE/CHRONIC HAZARDS:** This compound may cause skin irritation. When heated to decomposition this compound emits toxic fumes of carbon monoxide, carbon dioxide, NOx and SOx. (NTP, 1992)

4.3 Indication of immediate medical attention and special treatment needed, if necessary

Absorption, Distribution and Excretion

Following iv injection of 5 mg/rat mtu, 84-90% of dose ... recovered from carcasses ... after 1 min & 55-60% from carcasses of animals killed after 3 hr. after 3 hr, concn of mtu in thyroid was approx 1 mg/g of tissue.

SECTION 6: Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

6.3 Methods and materials for containment and cleaning up

Carcinogenicity

The Human Health Assessment Group in EPA's Office of Health and Environmental Assessment has evaluated methylthiouracil for carcinogenicity. According to their analysis, the weight-of-evidence for methylthiouracil is group B2, which is based on inadequate evidence in humans and sufficient evidence in animals. As a group B2 chemical, methylthiouracil is considered probably carcinogenic to humans.

12.1 Toxicity

12.2 Persistence and degradability

No data were found concerning the biodegradation of methylthiouracil either in natural media or in laboratory screening tests(SRC). Methylthiouracil may slowly biodegrade in natural waters and soil based upon the slow biodegradation of the structurally similar 2-thiouracil by activated sludge from municipal treatment plants(1,SRC).

12.3 Bioaccumulative potential

Based upon a water solubility of 533.2 mg/l at 25 deg C(1), a BCF of 18 can be calculated for methylthiouracil using a recommended regression equation(2,SRC). Based upon this estimated BCF, methylthiouracil will not be expected to bioconcentrate in aquatic organisms(SRC).

12.4 Mobility in soil

Based upon a water solubility of 533.2 mg/l at 25 deg C(1), a Koc of 138 can be calculated for methylthiouracil using a recommended regression equation(2,SRC). Based upon this estimated Koc, methylthiouracil will be expected to be highly mobile in soil(3,SRC) and will not be expected to significantly adsorb to soil, sediment or suspended particulate matter(3,SRC).

SECTION 13: Disposal considerations

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
