Absorption, Distribution and Excretion

Three mature ewes each received by intraruminal infusion a supplement of 0, 1, 2 and 3 g Mg/d in sequence over four 10-day periods. Net Mg absorption distal to the pylorus took place down its electrochemical gradient, although the quantity absorbed remained small during the control and first infusion periods. The bulk of Mg absorption occurred before the pylorus and, during the control and first infusion periods, took place against its electrochemical gradient. The net Mg absorption proximal to the pylorus rose with declining efficiency as Mg intake was increased. It is suggested that saturation of the absorption process at this site was occurring.
