## SECTION 4: First-aid measures

### 4.1 Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

### 4.2 Most important symptoms/effects, acute and delayed

SYMPTOMS: Symptoms of exposure to this compound may include severe irritation of skin and eyes, and temperature sensitivity to cold. ACUTE/CHRONIC HAZARDS: When heated to decomposition it emits very toxic fumes. (NTP, 1992)

### **4.3 Indication of immediate medical attention and special treatment needed, if necessary**
