### 4.1 Description of necessary first-aid measures

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

SYMPTOMS: Symptoms of exposure to this compound may include irritation.

ACUTE/CHRONIC HAZARDS: This compound is harmful if ingested, inhaled or absorbed through the skin. It may cause irritation. When heated to decomposition it emits

toxic fumes of carbon monoxide, carbon dioxide, nitrogen oxides, and hydrogen chloride gas. (NTP, 1992)
